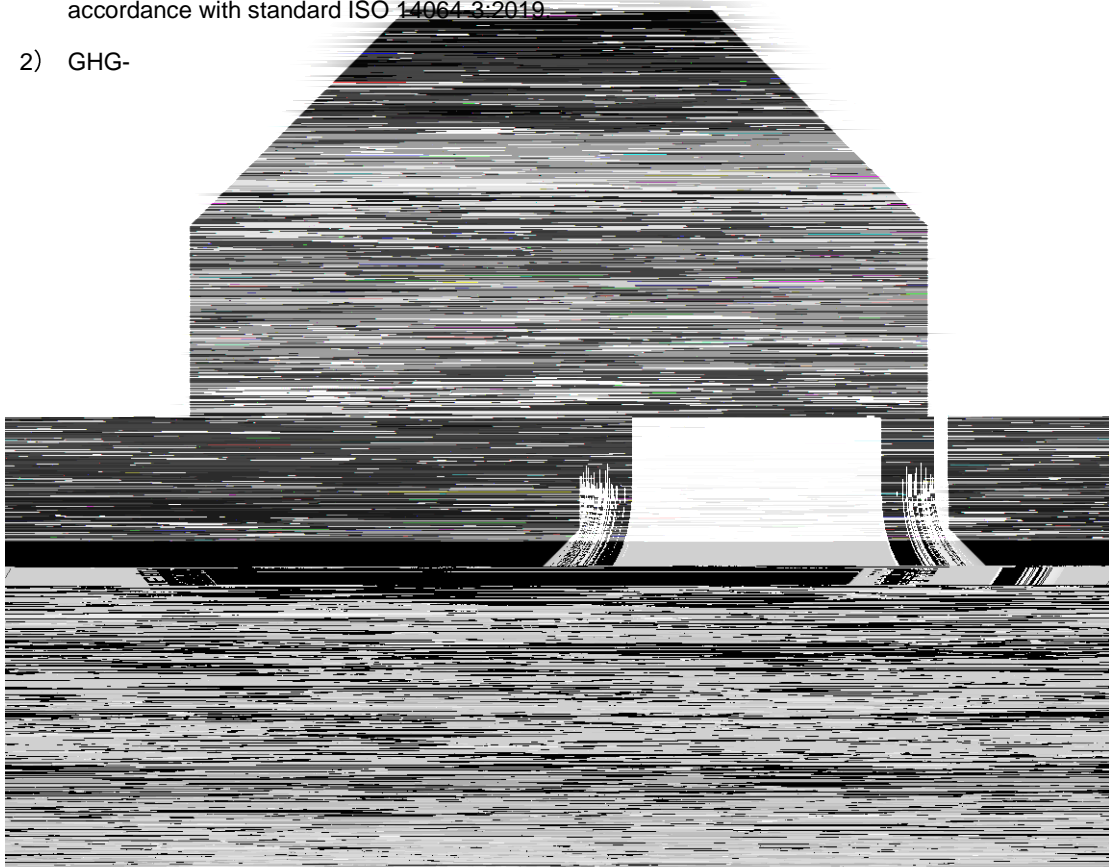
Background
